

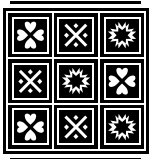
CRAFTS EXHIBITOR / TRADITIONAL ARTS DEMONSTRATOR GUIDELINES

41st Annual Appalachian Festival

Traditional Appalachian Crafts, Music, Storytelling,
Dance and Living History Demonstrations

The Appalachian Community Development Association, a non-profit organization whose purpose is to promote the educational, cultural, and social well being of the Appalachian population of Greater Cincinnati, has sponsored the Appalachian Festival since 1974. The **Appalachian Festival** began in 1970 as a project of The Junior League of Cincinnati.

The Purpose of the Appalachian Festival is to:



- ∨ Foster among Appalachian migrants in the Greater Cincinnati Area, a sense of pride in their heritage.
- ∨ Educate the general public about Appalachian Culture.
- ∨ Provide a marketplace for traditional hand-made Appalachian Crafts.
- ∨ Celebrate traditional Appalachian Music, Dance, Stories, Cooking and other cultural treasures.

SECTION I – The Crafts Exhibitor/Demonstrator Selection Process

To ensure the **highest quality** artisans and crafts, the Appalachian Festival requires all potential applicants to complete the selection process as follows:

A. THE WORK

1. **WORK MUST BE ORIGINAL AND EXECUTED BY APPLICANT(S).** We prefer that the artist stay on-site during the event. Other arrangements should be approved in advance of the event. Imports, kits, items made from kits, items made using commercial patterns, items made from parts of endangered species are not permitted. To be specific, simply attaching a purchased item onto a stick, pin, or clothing does not constitute handmade. **In selecting artisans, preference will be given to those whose arts and crafts are produced in an Appalachian tradition (i.e., weaving, carving, basket making), made by a traditional process, or a creative extension of a traditional craft or craft process.**
2. All applicants should submit four (4) professional quality photographs representing work to be offered for sale **and** one (1) photograph of their booth presentation. **The booth presentation photo is to jury the booth setup itself, NOT the items in the booth.** If the artisan cannot obtain professional photographs, the artisan should contact us for further instructions. All work to be exhibited or offered for sale, must be consistent with the photographs submitted. Each photo must be labeled with crafters' first and last name on the top back side. Photographs will be returned by mail to accepted applicants within 1 week of the close of the festival. Applicants not accepted will receive their photographs with their notification letter and refund

check. The Appalachian Festival is not responsible for damage to photographs or loss during return.

3. **FOOD ITEM VENDORS** may only sell pre-packaged food items prepared in a state-licensed facility. A copy of that license and a copy of their \$1 million liability policy listing the Appalachian Festival as an additional insured **MUST** also BE SUBMITTED WITH THIS APPLICATION.
4. The Appalachian Festival reserves the right to require removal of any work AND/OR artist(s)/artists' staff who attempt to sell any items that may be objectionable to the average public or non-approved items*.
 - **Non-approved items include:** anything NOT LISTED on this application, IMPORTS or any SUSPECTED BUY-SELL items! If we find that you're selling ANY of these, you'll be removed from our event immediately - with no refund.
 - **If you, yourself, do not make it - don't attempt to sell it here!**
 - **If you have any questions, please contact us first.**
5. All applicable items on the APPLICATION CHECKLIST must be submitted with the completed application to be considered.

B. **BOOTH OPTIONS**

Inside Booth or Outside Booth

Applicant provides their own white canopy tent, which is in good repair.

Inside Booths are in park pavilion style buildings, which have concrete floors and a roof, no sidewalls.

Outside Booth areas can either be graveled or grassy.

Traditional Arts Demonstrator Booth (If received on or before 5:00 p.m. on Jan. 8, 2010)

(Submit 2 additional photographs of artist demonstrating.)

Traditional Arts Demonstrators will be juried as a crafts exhibitor and separately as a demonstrator.

Demonstrator applicants must complete the full selection process. Once juried, you'll be notified by mail, of results. It is possible that you may qualify as an exhibitor and not qualify as a demonstrator.

In this case, you will be notified of your option to pay for the booth by Feb. 5, 2010.

C. FEES

Jury/Booth Rental fees are deposited upon receipt, therefore canceled checks do not mean acceptance. **CANCELLATIONS AFTER MARCH 26, 2010 WILL NOT BE REFUNDED.** Applicants not accepted will receive their photos, notification letter and refund check, on or about February 5, 2010.

D. SET-UP DAY:

1. **Thursday, May 6, 2010, 9 a.m. - 5 p.m.**
No earlier set-ups are permitted. Spaces not occupied by 5:00 p.m. will be filled with stand-by exhibitors with no refund.
2. Exhibitors are required to remain setup and operational during the Festival hours all (3) days of the event. Exhibitors leaving the show before closing may be refused acceptance in future Festivals.
3. **ONLY MEDICALLY NECESSARY WHEELCHAIRS, SCOOTERS OR FESTIVAL GOLF CARTS ARE PERMITTED IN THE FESTIVAL GROUNDS DURING SHOW HOURS; no recreational motor scooters, motorcycles or bicycles, etc.!**
Contact us, in advance of the festival, if you're planning on using any type of transportation inside festival grounds. No vehicles are permitted! Bring dollies to transport merchandise from **Festival parking lots!**
4. Because the Festival must comply with both health and fire regulations and is inspected by those agencies on a daily basis, coordinators have the right to make appropriate booth location changes to adhere to those regulations.
5. Coney Island is located on the Ohio River. May weather can bring 90 degrees and sunshine and could bring severe storms and cold weather. Be prepared for inclement weather and bring covers, tie-downs and weights.
6. Past experience has shown that ample inventory to support a minimum of \$5,000 sales in (3) days are needed to create an adequate display and satisfactory results for fellow artisans and festival coordinators as well. Booth appearance must be in harmony with the festival, which is a **family event**.
7. Absolutely no alcoholic beverages, drug paraphernalia or illegal substances are permitted in exhibitors' booths!
8. Because school buses transporting students, arrive as early as 8:00 a.m. on Friday morning, exhibitors must be set up by the end of day on Thursday. **All vehicles must be removed from Festival Marketplace by 7:30 a.m. on Friday morning.**

**DO NOT PARK IN THE SOUTH EAST SECTION OF
GATE #1's PARKING LOT ON FRIDAY!**

(It's near the gate where you checked-in).

IF YOU DO, YOUR VEHICLE(S) WILL BE TOWED AT YOUR EXPENSE!

Park all vehicles in the northwest end of the parking lot, back towards the grassy and graveled areas. Coney Parking attendants will direct you to the correct area.

9. Access to electricity is limited, however some outdoor spaces may not have any electricity available, plan accordingly. Heavy duty, three-wire grounded extension cords are required. No two-wire extension cords are allowed. Be prepared to run extension cords overhead or underneath as much as 50'.

E. BREAK DOWN

1. Approximately 150 Exhibitors and over 50 Living History Demonstrators' families will be breaking down and exiting at the same time! BE PATIENT!
2. Start breaking down after 6 p.m. on Sunday and pack booth up as much as possible.
3. Only after you're packed up, you can enter the festival grounds through the "check-in" gate. However, no vehicles will be permitted to enter the grounds until after our advertised show hours, all of the public is gone **and** festival management officially closes the show.
3. While loading your vehicle(s), **DO NOT BLOCK ACCESS TO ROADWAYS OR YOUR NEIGHBOR'S VEHICLE!**

F. MISCELLANEOUS

1. There is no discount pricing of items on Sunday.
2. Exhibitor's children must be under adult supervision at all times while on the grounds.
3. Only trained service animals are permitted in the Festival grounds.
4. Exhibitors are responsible for cleaning their own booth space.
5. The Appalachian Festival reserves the right to open gates up to one-hour early, if the crowds at the gate warrant it.
6. **The Appalachian Festival is staffed entirely by volunteers. Please give our volunteers courtesy and respect when requesting Festival services. Any exhibitor behaving in a disrespectful manner towards volunteers will be asked to leave the grounds immediately (with no refund) and will not be invited back the following year.**
7. Coney Island will be providing both day and night security. However, The Appalachian Festival, The Appalachian Community Development Association and/or Coney Island Properties will not be responsible for, or liable in any way, for damage to, including weather, or theft of exhibitor's work or person. If you wish to have your items insured, they must be insured through your homeowner's or business policy. Since there may be other activities scheduled in the Coney Island and/or Riverbend facilities, please bring covers for your displays, if you feel you need them.
8. You agree to expressly release the producer "Appalachian Festival / The Appalachian Community Development Association / all agents acting on behalf of the producer" from any and all liability for any damage, injury or loss to any person or goods or property which may arise from the licensing and occupation of the exhibit space by the applicant(s) and agree to hold and save the Producers harmless from any loss or damage by the reason thereof.

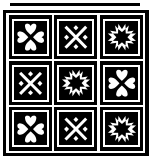
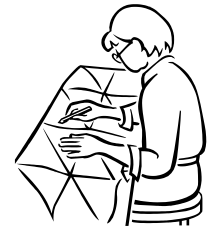
